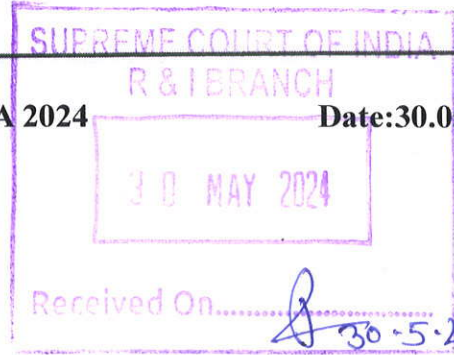

SUB: UPLOADING THE APPROVED MENTIONING LIST ON THE SUPREME COURT WEBSITE.

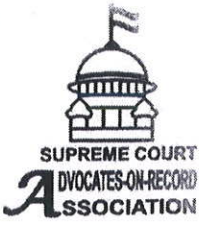
Respected Sir,
