**SUB: REQUEST FOR MEDICAL SHOP & VENDING
MACHINES IN THE SUPREME COURT
PREMISES.**

Respected Sir,

While the recent facilities installed in the Supreme Court premises for the Advocates and Litigants are quite encouraging, a few additional requirements are needed.

As per the discussions with various members and suggestions in this regard, there is a requirement of a small medical shop/counter within the Supreme Court premises, preferably near Library-1 on the first floor. This facility would provide immediate access to first-aid and over-the-counter medicines for common ailments such as headaches, nausea, pains, cold & flu, and menstrual cramps, thereby providing timely relief to members of the bar, and ensure the health and well-being of all the court's stakeholders.

Currently, the Apollo Medical Shop in the Chamber Block opposite Gate D is the only one which is used by the members, litigants and clerks.

However, it is often physically impossible to travel that distance between matters, especially when in severe pain or in emergency. This situation not only causes inconvenience but also hampers the smooth functioning of the court. This could be
