SUPREME COURT

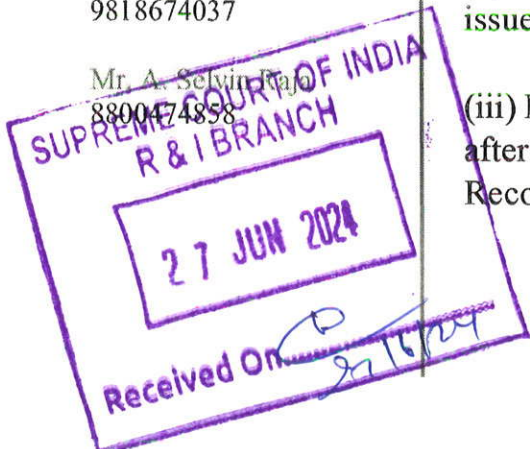
Respected Sir,

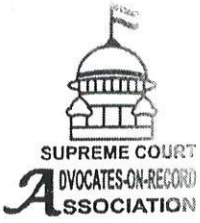
The aftermath of the Covid-19 Pandemic and the reopening of the Supreme Court physically for advocates and litigants, saw some significant changes which were required keeping in mind the health and safety of all individuals.

However, considerable time has since lapsed, and it is therefore requested that some modifications be made to the instructions, specifically regarding the issuance of Entry passes which is a cause of concern amongst most of our members.

In furtherance thereof, the following remedial measures are required to be adopted at the earliest –

- (i) Two entry passes per matter be allowed to be issued.
- (ii) In Tagged Matters/Group Matters – One entry pass may be issued per matter.
- (iii) Provisions for issuing passes for oral mentionings as well, after due endorsement/approval of the concerned Advocate on Record.
